

The Official "THE RACING BIZ MAY 13, 2017 CONTEST" Contest rules

1. ELIGIBILITY

NO PURCHASE NECESSARY. The **"THE RACING BIZ MAY 13, 2017 CONTEST"** ("Contest") is a game of skill, with a chance component, sponsored by TheRacingBiz.com and open to legal residents of the United States and Canada, **21 years of age** or older. Employees, officers, directors, shareholders, agents, representatives, and immediate family members of The Racing Biz and its parent companies, affiliates, subsidiaries, and advertising and promotion agencies, are not eligible to win prizes. In the event that such a person participates and achieves a score that would otherwise earn him or her a prize, that prize will be given to the eligible player with the next highest score. **CONTEST IS LIMITED TO PEOPLE WHO HAVE ACTIVE E-MAIL ADDRESSES DURING THEIR PARTICIPATION IN THE CONTEST. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

2. HOW TO ENTER

Entry into the Contest is FREE. All entries for the Contest must be received by a time to be announced on TheRacingBiz.com on Saturday, May 13, 2017. All entries become the exclusive property of TheRacingBiz.com.

You can enter the Contest via computer by filling out the online registration form. Once you have submitted the completed registration form, TheRacingBiz.com will confirm your entry via electronic communication. Each individual player may enter the Contest twice. In other words, **NO PLAYER MAY HAVE MORE THAN TWO PLAYER IDS AND PASSWORDS.** If a player has more than two entries, **ALL** entries from that player may be disqualified.

A player who won a prize in The Racing Biz Kentucky Derby 2017 is not eligible to win a prize in this contest.

Contest entries will be disqualified at the sole discretion of TheRacingBiz.com if you attempt (i) to enter the Contest through any means other than those outlined in these Rules; or, (ii) to disrupt the Contest or circumvent the terms and conditions of these Official Rules. And, if either of the above occurs, TheRacingBiz.com reserves the right to remedy any such action, disruption, or circumvention in a manner, determined solely by TheRacingBiz.com that is fair and equitable to Contest participants.

All contestants agree to receive future Contest announcements as a condition of entering. A player who has "unsubscribed" from The Racing Biz mailings and not re-subscribed as of the time of entry, or is not subscribed at the time of notification of winners, is not eligible to win a prize in this contest.

3. DURATION

The Contest will be one day in duration on Saturday, May 13, 2017.

4. HOW TO PLAY

- The contest will feature three races, all from Pimlico Race Course's Saturday afternoon card: races 6, 7, and 8.
- In each race, each player will place three mythical wagers: \$2 to win on your chosen "win" horse, \$2 to place on your chosen "place" horse, and \$2 to show on your chosen "show."
- Each wager must be on a different horse.
- In the event that one or more of a player's horses scratches, the player will NOT receive an alternate horse in that spot.
- Players will accrue points based on the results of the mythical wagers.

In the event that more than two players are tied for first place, or more than one tied for second, the following tiebreakers will be used in order to whittle down the list of winners:

- The player(s) who picked the largest number of horses in the proper spots (i.e., "win" horses who won plus "place" horses who finished second plus "show" horses who finished third).
- The player(s) who picked the largest number of winners with their win horses.
- The player(s) who picked the largest number of winners with their place horses.
- The player(s) who picked the largest number of winners with their show horses.
- Random draw from among all players tied for tied for the final spot(s).

ALL MONEY WAGERED OR WON IN THE CONTEST IS HYPOTHETICAL.

5. PRIZES AND WINNERS

Two winners, determined by the method outlined in Section 4, will receive a \$100 win wager on the Preakness Stakes May 20. By entering this contest, players specifically consent to the use of their names, voices, and likenesses by TheRacingBiz.com.

To collect the prize, players will either:

- If present at the Preakness Stakes, place the wager at a mutually agreed upon time with representatives of TheRacingBiz.com..

- If not present at the Preakness Stakes, players must inform TheRacingBiz.com via email of their selection no later than 1:00 p.m. EDT on May 20, 2017. If a winning player does not make a wager by that time, s/he forfeits the wager.

Winners have not won \$100. Instead, they have won the right to direct a free WIN wager in the amount of \$100 on one horse competing in the Preakness Stakes.

The winner of the Contest is responsible for any expenses related to the prize, including any applicable tax, insurance, etc. The Winner will be notified in an email on or before May 16, 2017. The Winner will be announced on the TheRacingBiz.com Web site and in an email to all registered players on or before May 16, 2017. In the event Pimlico cancels its May 13 card, or cancels one or more of the races in the chosen sequence, TheRacingBiz.com may, at its sole discretion, a) cancel the contest or b) declare a winner based on random draw among all participants, or c) continue the contest until such time as all scheduled races have been completed.
